

About this trade data report

This trade data report provides insights into the trade flows between a number of **Southern African AGOA beneficiary countries** and the United States.

The data is based on official U.S. import statistics. A general overview is provided with aggregate two-way trade between the Southern African country and the U.S. (imports, exports, balance of trade), in tabular and chart format. A second chart categorizes U.S. imports with each country by import category (AGOA, no preferences claimed, etc.).

For each country, trade data by sector is shown for the past three years (2019-2021), along with 2022 data for the first quarter. This includes imports and exports, and further distinguishes U.S. imports by aggregate and by share of AGOA/GSP preference.

Disaggregated data tables for each country show U.S. imports by HTS 4-digit classification, in descending order by value, irrespective of a product's preference status. This provides greater insight into the leading tariff lines being imported into the U.S. from the country concerned. The final data table shows only products that entered the U.S. duty-free under AGOA/GSP preference, for each country, and indicates which tariff lines (at the HTS 8-digit level) are benefiting from these trade preferences.

Summary:

Angola has been a net exporter to the United States during the review period (2000-2021), with combined two-way trade increasing from \$3,568m in 2020 to \$19,269m in 2007, before declining to \$1,459m in 2021.


During 2021, the value of U.S. exports more than doubled (+113%) over the previous year, while imports declined by 5%.

While Angola has been a significant exporter under AGOA preference, most of this trade has been concentrated in the energy sector. Petroleum oils (mostly crude) account for the bulk of Angola's exports to the U.S., followed by diamonds.

Other smaller product categories have included certain steel products, sulfur, acrylic hydrocarbons, headgear and coffee. AGOA preferences are only being claimed on petroleum products.







Summary:


Botswana has been a net exporter to the United States during the review period (2000-2021), with combined two-way trade increasing from \$72m in 2000 (the year during which the AGOA legislation came into force) to \$863m in 2017, the highest level in recent years. Since then, two-way trade has declined to \$300m, albeit on the back of a 42% increase in U.S. exports over the previous year.

Botswana's utilization of AGOA preferences has been modest. Since 2000, \$224m worth of Botswana's exports entered the U.S. under duty-free preference (AGOA / GSP), mostly during the mid-2000s. During the 4-year period 2018-2021, no direct trade under AGOA was recorded. Some Botswana-made goods may enter the U.S. market indirectly, for example when exported to other AGOA beneficiaries as intermediate products.


Products falling into the broad 'Minerals and metals' category form the bulk of Botswana's exports to the U.S. currently. These comprise mostly diamonds (classified under HTS 7102).




Eswatini (formerly Swaziland) has recorded significant trade with the United States, and was a net exporter between 2000 and 2014, before exports declined drastically following the country's suspension as a beneficiary of AGOA preferences. Eswatini has subsequently regained AGOA status and has seen U.S.-bound exports increase gradually. Imports from the U.S. have often exceeded exports since then, and the country has recorded trade deficits with the U.S. since 2015.

In 2004 and again in 2005, the value of Eswatini's U.S. exports were \$199m, driven by strong apparel exports on the back of AGOA's favorable rules of origin provisions which allowed the use of third country fabrics, combined with the global trade regime around textiles and apparel trade, which at that time still placed heavy restrictions on U.S. imports from China in the context of the WTO Multifiber Agreement (MFA) / Agreement on Textiles and Clothing (ATC). Despite U.S. exports declining subsequently, they remained resilient until the country's AGOA suspension.

Today, Eswatini's main exports to the U.S. comprise sugar, fruit (mainly grapefruit) and textile goods (apparel). Most trade in these categories enters the U.S. under AGOA preference.






Lesotho's trade with the United States takes place on an almost exclusively one-way basis, that is, Lesotho exports a significant value of goods to the U.S. versus very few imports. Since 2000, Lesotho's already sizable apparel exports to the U.S. received a boost through AGOA's generous Rules of Origin provisions, which provided Lesotho with the flexibility to source input materials without any associated geographic restrictions.

Along with Kenya, Lesotho is one of the largest producers and exporters of apparel to the United States. SInce 2002, the value of apparel exports has exceeded \$300m in each successive year, reaching a high in 2004 (just prior to the expiry of the Mulifiber Agreement / Agreement on Textiles and Clothing, the WTO's global quota regime).

Lesotho's exports to the U.S. comprise mainly textile goods (apparel) and precious stones (diamonds), the former qualifying under AGOA, while diamonds are duty-free under the U.S.' MFN tariff regime.






Malawi has consistently enjoyed a trade surplus with the United States during the review period, during which time exports have remained broadly constant, mostly between \$50m and \$75m per annum.

The largest export category from Malawi to the U.S. comprises agricultural products: mainly tobacco, tea, nuts (mainly macadamia) and sugar, with a combined value in 2021 of \$46m. Two-thirds of these exports qualified for AGOA preferences.

Previously, Malawi also exported sizable volumes of apparel to the U.S., although in recent years, these exports have declined significantly, with only small quantities of knitwear being exported to the U.S. in recent years (under AGOA preference).






Mozambique has been mostly a net importer of goods from the United States, particularly over the period 2007 - 2015. Since 2013, Mozambique's U.S.-bound exports have increased steadily, resulting in somewhat more balanced two-way trade and only small trade deficits.

Exports to the U.S. comprise mainly mineral products, lead by precious stones (not diamonds) and titanium ores. Other exports include graphite, and agricultural goods such as sugar, nuts, tobacco, fish, and fruit.

Mozambique also exports goods under AGOA preference. In 2021, around \$8m worth of goods were able to claim AGOA status, of \$160m in total exports. The value of duty-free AGOA / GSP exports has remained relatively constant over the past five years, with most other goods entering the U.S. duty-free on a MFN basis.







Namibia's exports to the United States reached a peak of \$436m in 2011, before declining up until 2015. Since then, U.S. bound exports have once again seen growth, which has also over the past two years resulted in a trade surplus.

With the exception of 2011 and the period 2002-2007, when Namibia successfully exported apparel to the U.S. using its favorable Rules of Origin provisions, Namibia's exports under AGOA have for the most part been modest relative to overall exports. Since 2018, AGOA exports have seen some growth, and have since then predominantly consisted of building stone (granite) and marble.


On 20 September 2016, Namibia became the first (and currently only) African country to receive authorization from the US Department of Agriculture to export raw beef / veal to the US. This follows a lengthy application and audit process underway since 2002. This is subject to ongoing monitoring, as well as further inspection at the U.S. port of entry.

In 2020, Namibia finally exported its first (and currently only) shipments of beef (*'meat of bovine animals, frozen'*), worth \$2.7m, to the U.S., accounting for almost 90% of Namibia's agricultural product exports to the U.S. during that year.

Non-AGOA exports over the past few years have included diamonds as the largest export category, as well as smaller volumes of vegetable oils, fish, wood charcoal and others.





Zambia's two-way trade with the United States over the period under review has fluctuated significantly, but in recent years has seen two peaks: first in 2018, and again in 2021, where U.S.-bound exports exceeded \$200m and \$180m respectively.


Between 2006 and 2020 - with the notable exception of 2018, Zambia recorded a trade deficit in its goods trade with the U.S. In 2021, Zambia's U.S.-bound exports significantly exceeded U.S. imports. During that year, the country imported \$85m worth of goods from the U.S., with exports valued at just over \$180m.

Leading exports are refined copper and copper anodes, and precious and semi-precious stones, which have seen significant year-on-year fluctuations in the value of exports. Since the country's copper exports qualify for AGOA preferences, AGOA/GSP utilization rates are strongly tied to this. Overall, however, the value of Zambia's AGOA exports has been relatively low.

Coffee exports, which benefit from a duty-free import regime in the U.S. have seen strong growth recently, and are now one of the country's largest export products to the U.S. apart from natural resources. Ferroalloys, diamonds and honey are also important exports, with honey qualifying under AGOA.





Summary:

South Africa is the U.S.' largest trade partner in Sub-Saharan Africa. Exports to the U.S. grew strongly during 2021 and reached their highest ever level at \$15.5b, while imports from the U.S. were valued at \$4.7b in that year. During the period under review, South Africa recorded a significant surplus in its trade with the U.S., having reached \$10.7b in 2021, a 46% increase over the previous year.


The largest category of exports to the U.S. comprises minerals and metals, mostly platinum and diamonds. Each tariff line has seen year on year growth since 2020 of over 80%. Motor vehicles are South Africa's third-largest export category to the U.S., and the largest under AGOA preference. Various other resource-based goods also qualify for duty-free export under AGOA.

Agricultural products benefiting under AGOA are nuts - mainly macadamia nuts - and citrus (mainly oranges). South Africa, along with Kenya, together account for much of the total U.S. import market of macadamia nuts. South Africa is also a leading supplier of oranges to the U.S., along with mandarins. Wine also qualifies under AGOA, and over \$30m worth of bottled wines has been imported from South Africa in each of the past three years.

South Africa's overall utilization of AGOA/GSP preferences was 17% during 2021, with most of the remaining trade also entering the U.S. duty-free on a MFN basis.




